CRIMINAL INVESTIGATION REPORT

CASE: 21MI0478

OFFICER: Fortier, Adam

CASE INITIATION:

On 07/17/2021 I received an inmate complaint form from Inmate Francis Sepulveda. The complaint was regarding inappropriate actions of former Deputy Eric Watts.

One allegation was E. Watts accidently came into contact with her (Inmate Sepulveda) breast while they were standing close to each other. Another allegation was E. Watts was having sex with another inmate named Amanda White. A third allegation was E. Watts made inappropriate sexual comments towards Inmate Sepulveda during her booking process.

After interviewing all current inmates all of whom stated Inmate Sepulveda informed them when she was first booked in E. Watts made sexual comments towards her but she stated she played into it to get special treatment, but they noticed nothing inappropriate involving E. Watts.

Upon attempting to watch video of E. Watts and Inmate Sepulveda and the kitchen where the alleged sexual activity occurred during the described time, I learned the video was no longer available.

I contacted Amanda White and asked her about the allegations she had a sexual relationship involving E. Watts while she was confined to the Mineral County Detention Center, Amanda White denied any sexual relations occurred.

INVESTIGATIVE ACTIVITY:

On 08/23/2021 I was contacted by Inmate Sepulveda who asked if she could talk to me. During the conversation with Inmate Sepulveda, she informed me the other women in her cell asked why none of the other female inmates liked her.

Inmate Sepulveda stated she explained she had been involved in several physical altercations with other inmates and filed a complaint against former Deputy Eric Watts

Inmate Sepulveda continued by explaining during the conversation Inmate Libbee who was confined to a single person cell overheard what they were talking about and stated she had sold E. Watts drugs and was having a sexual relationship with him.

While I was unsure if providing this information was a way to assist Inmate Libbee in getting out of a lock down cell or if the information was accurate, I contacted Chief Barnes

of the Walker River Tribal police and provided him with the information. I did not interview Inmate Libbee at that time.

It should be noted Inmate Libbee was in a lock down cell for making deputies believe she was in fear for her safety from Inmate Sepulveda which turned out to be untrue so she (Inmate Libbee) could be moved into the other women's cell to be closer to her friends.

While determining Inmate Libbee had lied about being in fear of her safety I learned she asked Inmate Sepulveda to also lie and say she could not be around Inmate Libbee.

On 08/25/2021 Chief Barnes and Officer Roman Sanchez from the Walker River Tribal Police arrived to interview Inmate Libbee.

After Chief Barnes and Officer Sanchez completed their interview of Inmate Libbee they informed me Inmate Libbee admitted to having a sexual relationship with E. Watts and meeting up with him at the Chevron gas station near Safeway located in Hawthorne Mineral County Nevada to sell him pills. Chief Barnes stated Inmate Libby indicated the evidence would be on her cell phone.

I made contact with Inmate Libbee and asked her if I could look through her phone. Inmate Libbee stated I could but her phone was at a friend's residence. Inmate Libbee agreed to have the phone brought up to me and allowed me to go through it.

Before receiving the phone, I interviewed Inmate Libbee, she described her cell phone as a black Android phone from Verizon.

Inmate Libbee stated she received money from E. Watts and in return she gave him oral sex. Inmate Libbee stated this happened two times and each time E. Watts gave her \$60 dollars.

Inmate Libbee also informed me she had meet with E. Watts at the Chevron near Safeway located in Hawthorne, Mineral County Nevada. Inmate Libbee stated while there she talked to E. Watts about providing him pain pills.

While not being asked Inmate Libbee commented about knowing E. Watts and Amanda White were engaged in a sexual relationship while she was an inmate in the Mineral County Detention Facility.

Inmate Libbee stated she had received this information from Amanda White and they had talked about it over chat in Facebook messenger which was also on her cell phone.

Inmate Libbee also stated Jimmy Robinson was also asked by E. Watts for pain pills. Inmate Libbee stated her and J. Robinson had talked about it over text messages.

I contacted J. Robinson over the phone and asked him about the allegations E. Watts had asked for pain pills. J. Robinson informed me he had done some work for E. Watts at his residence and E. Watts had gotten hurt. J. Robinson stated E. Watts had asked him for ibuprofen 800 or something similar for the pain.

Inmate Libbee also advised me she had sent pictures and messages through snapchat. I know snapchat to delete pictures once looked at but the messages generally stay and are able to be read.

I was also advised by Inmate Libbee she had been sending E. Watts nude pictures on numerous messaging apps in exchange for money.

At approximately 1700 hrs, the phone was brought to the Mineral County Sheriff's Office and handed to me.

I first checked Inmate Libbee's Facebook messenger. I observed the first message between Inmate Libbee and E. Watts was July 11.

During the conversation E. Watts asks if Inmate Libbee has a snapchat. After some conversation about the app, it appears they added each other's user name to their account.

During the conversation E. Watts refers to Inmate Libbee as a criminal and even asks her if she is making money from the Sheriff's Office by setting him up, then comments he was joking.

Inmate Libbee asks E. Watts for money, he responded "I'm sure you can find something to do to earn it" After Inmate Libbee shows him a picture of her "cash app" he comments he is a cash only person.

Inmate Libbee comments talking to her is not a crime but it may be in Mineral County. E. Watts comments "everything is a crime in Mineral County even the shit they make up".

It did appear there were missing text messages between the two.

I then checked Mande Whites messages to and from Inmate Libbee. While looking through the messages there was nothing mentioned about any sexual activity between Amanda White and E. Watts as Inmate Libbee indicated there would be.

I then checked all messages to E. Watts phone number.

The first message between the two was on July 25th 2021. Watts asks Inmate Libbee how he was supposed to know it was her as it could have been a set up. Inmate Libbee responded by stating she was going to send him something he would be able to blackmail her with to prove she was not setting him up.

E. Watts offers to give Inmate Libbee money but comments not to "burn" him as it "could be bad".

Inmate Libbee commented E. Watts was only one of 2 cops she could trust, E. Watts commented "it is wild here with how shit works lol".

When Inmate Libbee asks in E. Watts was going to be home he comments he would be and "you can come over for a servicer and I can spot you some cash".

When Inmate Libbee asked if that was code for something E. Watts stated "you can call it what you want Imfao".

- E. Watts also asks Inmate Libbee to not park in front of his residence so the cops will not know when she is there.
- E. Watts also askes Inmate Libbee to keep the information about them to herself.

Inmate Libbee asks E. Watts how he was doing he responded "Its Ok just working like a black man's no afence for my room and board lol yelling at dispatch and shit you know same ol same".

E. Watts told Inmate Libbee "truly makes me laugh this fuck wouldn't know what to do if I dropped them in gangland I grew up and worked they would eat theses cops alive lol".

Watts does mention in a message he is waiting in the parking lot of Chevron for Inmate Libbee but never says why he is waiting there.

Inmate Libbee stated at this meeting is when E. Watts asked her to provided him with pain pills. Inmate Libbee never stated why she was meeting E. Watts in a parking lot.

It also appears there are missing messages.

After talking to Inmate Libbee I was unable to substantiate any of her claims as the information she stated was in her phone messages was not.

I attempted to look at snapchat messages but the app had been deleted from her phone.

I received a written statement from Inmate Libbee.

Inmate Libbee stated after getting out of rehab, she was contacted by E. Watts and asked to download Snapchat.

Inmate Libbee stated she asked E. Watts for money, that is when he asked what he was going to get out of it. Inmate Libbee stated she sent him pictures, to which he responded that was not good enough.

Inmate Libbee stated E. Watts then invited her over to his house where she was given \$60 dollars in exchange for a "blowjob".

Inmate Libbee continued by stating E. Watts had asked her if she had heard of any investigation involving him having sex with Amanda White while she was incarcerated in the Mineral County Detention Facility. Inmate Libbee stated she told E. Watts she had not heard anything.

Inmate Libbee continued by stating she had a conversation with Amanda White on Facebook messenger where she (Amanda White) admitted to having sex with E. Watts while she was incarcerated.

Inmate Libbee also stated in the written statement she had meet with E. Watts at the Chevron located next to Safeway where she was given more money by him. Inmate Libbee continued by stating at that meeting E. Watts asked her to get him pain pills and stated he wanted "oxy".

After reading all the messages between Inmate Libbee, E. Watts and Amanda White I was unable to locate the information Inmate Libbee stated would be there so I was unable to substantiate her claims.

I was also unable to substantiate the claims made by Inmate Sepulveda as the video recordings from inside the jail at the time of her described incidents were already gone.
